Horizon Europe pending Work Programmes 2021-22 published

Brussels, 17,6,2021

The European Commission has published the pending Horizon Europe Work Programmes 2021-2022 on 15 June 2021, including e.g. Marie Sklodowska-Curie Actions the Food cluster

These official calls, in combination with hints from the EPSO Brief on the Draft Work Programme which was published on the members only website 5.5.2021, can further advance your proposals.

You find in the EPSO Brief on pages 39-43 the cluster topics relevant for plant scientists – this will help you to find the full call text in the EC published WP without having to read it in full.

Most relevant are:

1 - Details on the Work Programmes:

The basic individual work programmes structure has been broken down into destinations, calls and topics:

<u>Destinations</u>: The destinations assigned to each part of the programme provide the general framework for the content of the individual work programmes. The respective long-term social, economic and scientific effects (expected impacts) that are expected from the projects in this destination are also defined at this level.

<u>Calls:</u> The destinations are assigned annual, in some cases several annual calls for proposals for 2021 and 2022. The relevant information on the calls, such as its opening and closing dates and a list of the individual topics with budget information, are now placed in front of the calls in an overview table.

<u>Topics</u>: The general call information is followed by detailed descriptions of the individual topics encompassing the respective call. The topic structure has changed in the way that the budget and project type as well as specific conditions of the topic are listed in a table directly after the title, followed by the medium-term effects to be achieved by the projects (expected outcome) and the tasks to be carried out in the projects (scope).

The "Rules for participation and dissemination" form a crucial part of the Horizon Europe Regulation. They are the legal basis for the implementation of research projects and include the general rights and obligations for participants in Horizon Europe as well as principles for use and dissemination of results.

KoWi has summarized the most important points and novelties of the Rules for Participation in comparison to Horizon 2020 in a factsheet which can serve as a preparatory document for Horizon Europe. The factsheet is only available in German.
